

**Second public notice for the acquisition of expressions of interest

This notice is finalized, pursuant to art. 10, paragraph 1 of the Italian Ministry of Foreign Affairs Regulation no. 192/2017 and later amendments, on procedures for the stipulation of contracts to be carried out abroad, to acquire expressions of interest from economic operators potentially interested in participating in a procedure announced pursuant to art. 7, paragraph 2, letter. b) of the same Regulation.

The contract has an estimated value of € 592,000.00 excluding KDV.

The concession criterion will be that of the lowest price

All subjects who, at the time of submitting the application, meet the following requirements can submit an expression of interest to participate in the procedure referred to in this notice:

- absence of causes of exclusion pursuant to art. 80 of the Legislative Decree. 50/2016,
- non-existence of the disqualifying cause referred to in the art. 53, paragraph 16-ter, of the Legislative Decree. Lgs. n. 165/2001,
- absence of any other situation that determines the exclusion from tenders and/or the inability to contract with the public administration, according to current Italian legislation
- professional technical skills for the service to be provided and experience previously acquired in the sector;
- solidity of the company's financial structures, demonstrating solid economic and financial capacity.
